*Friday, November 2nd from 3:00–8:00 pm and Saturday, November 3rd, at 6:30 a.m. for exhibitors only.

*All participants must check in by 7:30 a.m. Saturday morning. Please have your displays ready by 8:30 a.m.

First Baptist Church, promoters and volunteers are not responsible for any damage or loss due to fire, theft, or by any other means.

*Each space is clearly marked with tape and may not extend beyond the 8' x 6' limit.

*Please do not dismantle your display until the end of the show.

- All items to be sold must be *predominately hand-crafted* by the applicant unless craft is a personalization or an enhancement. NO commercial, whole sale, or flea market items are allowed. No items made from KITS. Also, raffles are not permitted
- The Boutique reserves the right to prohibit sale of crafts deemed objectionable including but not limited to: **pictures or products related to alcoholic beverages, smoking, drugs or gambling, items such as Halloween characters, mystical themes, toy weapons, and/or crafts displaying offensive or objectionable words, are absolutely NOT PERMITTED for display.** You are expected to be self-policing, please keep in mind this is a church-related show. If a member of the committee finds such an item on display, the items must be removed. Noncompliance is reason for not being invited back to the show.
- Only craft items listed on your application may be displayed. Acceptance and placement of crafters are made based on crafts listed. Additions or changes may be made only with prior written request by the crafter and approval of the Boutique Committee. In order to present a variety of crafts the Boutique reserves the right to limit the number of similar crafts to be displayed, as well as limiting the number of double spaces. The church operates food concessions, and it is requested that no edible items be sold at craft tables without written approval of the committee. Bottled beverages are not to be sold.
- No smoking is allowed in the building. You may smoke in the outdoor designated area behind the dining rooms. Eating will be permitted only in designated areas (where refreshment are available). Only Crafter beverages with covers/lids may be taken to your spaces. A crafter's private dining room is provided for your convenience.
- If you find that you are unable to participate, please let us know so that we can assign the space to someone on the waiting list. The committee will decide who would replace this spot
